DEFENDANTS' VERIFIED COUNTERCLAIM AGAINST PLAINTIFF

Now comes Defendants/Counter-Plaintiffs, Glen Neal Boiko ("Boiko") and Highway Stars, Ltd. ("Highway Stars"), an Illinois corporation, (hereinafter collectively referred to as "Highway Stars"), by and through their undersigned attorneys and for their Verified Counterclaim against Plaintiff/Counter-Defendant Paul Castelbuono, a/k/a "Paul Castle" and d/b/a "World of Motorworks" (hereinafter collectively referred to as "Castle"), and further support thereof states as follows:

NECESSARY PARTIES

- 1. Highway Stars is an Illinois corporation with its principal place of business located at 1556 St. Paul Avenue, Gurnee, Illinois. See IL Sec. of State Corporation File Report Attached as Exhibit A.
- 2. Glen Neal Boiko is President and owner of Highway Stars. Mr. Boiko resides in Northbrook, Illinois. See ¶¶ 2 and 3 of the Affidavit of Glen N. Boiko Attached as Exhibit B.
 - 3. Paul Castle is an individual residing in Aurora, Illinois. Complaint ¶ 1.
- 4. World of Motorworks, a dissolved corporation, is a sole proprietorship with its principal place of business located at 1723 E. Wilson, Batavia, Illinois. See IL Sec. of State Corporation File Report Attached as Exhibit C.
 - 5. Castle is the sole proprietor of World of Motorworks. Complaint ¶ 2.

JURISDICTION AND VENUE

6. This Court has jurisdiction over this matter pursuant to 735 ICS 5/2-101 because Counter-Defendant Castle is a resident of Kane County, Illinois.

GENERAL FACTS

- 7. Highway Stars is a supplier of specialized, new original and genuine General Motors automotive parts and original equipment manufacturer ("OEM") parts for the Buick Grand National, Turbo Regal and GNX. Highway Stars holds the special distinction of being an authorized stocking jobber of AC Delco parts, authorized stocking distributor of Delphi parts, official Authorized GM Restoration Parts licensee and official General Motors Service Parts Operations Program ("GMSPO") licensee. See Exhibit B ¶¶ 7 through 10.
- 8. Highway Stars distributes all of its licensed products pursuant to the General Motors License Agreement. See Exhibit B ¶ 11.

- 9. The sale of General Motors licensed products accounts for a substantial portion of Highway Stars' revenue. *See Exhibit B* ¶ 14.
- 10. A violation of the General Motors License Agreement could terminate Highway Stars' contractual right to distribute specialized, new and genuine General Motors automotive parts and original equipment manufacturer ("OEM") parts for the Buick Grand National, Turbo Regal and GNX automobiles. See Exhibit $B \P 12$.
- 11. The General Motors License Agreement provides, in relevant part, "Licensee agrees that it shall not conduct any activity or produce goods which it knows or should know will in any way question Licensee's ethics or lawful practices, nor shall Licensee . . . do anything which it knows or should know will damage or reflect adversely upon Licensor (including its image, reputation, and products), the Licensed Products, and/or the Licensed Trademarks (and other GM Trademarks)." See Exhibit B ¶ 13.
- 12. Highway Stars' sales are primarily derived from its website, <u>www.nos4gn.com</u>, which displays images of its inventory and information pertaining to the history, use and installation of its products. See Exhibit D and Exhibit B ¶ 15.
- 13. In addition to generating sales from its website, Highway Stars conducts a significant amount of business through its eBay retail listing. As an eBay retailer, Highway Stars operates under username "nos4gn_highwaystars" and possesses a perfect feedback record, five star (highest) customer satisfaction rating and is regarded as an eBay Top Rated Seller. See Exhibit $C \, \P \, 16$.
- 14. Among Buick Grand National, Turbo Regal and GNX enthusiasts and collectors ("Buick Community"), Highway Stars is a trusted supplier of new original, genuine and official General Motors, AC Delco and Delphi automotive parts. See Exhibit B ¶ 17 through 19.

- 15. Highway Stars is widely known and admired for its record of accurate advertising, fair pricing and impeccable customer service.
- 16. World of Motorworks is an unincorporated operation that claims to be "owned and operated by a group of individuals who have had a 20 year infatuation with Turbo Buicks", one of which is Castle. See Exhibit E.
- 17. World of Motorworks holds itself out as "specializing in Camaro, Corvette, Mustang, GS, GNX and Buick Grand National Parts and Accessories". See Exhibit E.
- 18. World of Motorworks also sells automotive parts through its website, www.worldofmotorworks.com, however, it does not stock nor is it licensed to sell/produce General Motors restoration parts. In addition, World of Motorworks does not specialize in the sale of new original AC Delco and Delphi automotive parts. See Exhibit B ¶ 20.
- 19. On information and belief, Castle has a reputation for purchasing new, genuine, original and official General Motors, AC Delco and Delphi automotive parts from Highway Stars and other retailers and creating counterfeit replicas that he then markets as "authentic", "rare" or "original" at or above market price. See Exhibit $B \, \P \, 21$.
- 20. Castle purchases these new, genuine, original and official General Motors, AC Delco and Delphi automotive parts from Highway Stars' eBay retail listing under usernames (a) "carguyjr", (b) "pauljr129" and (c) "turbochick129".
- 21. Castle's "carguyjr" eBay feedback is a true and accurate representation of his business dealings and reputation among the Buick Community. See Exhibit F. Castle's "carguyjr" feedback profile provides, in relevant part:
 - a. "One buys, they pay and receive nothing. A disgraceful eBay seller. Period."
 - b. "Have patiently waited a month... Nothing. Filing for a refund with PayPal..."

- c. "SCAMMER!!! Beware of this guy!"
- d. "NEVER SHIPPED, NO COMMUNICATION HAD TO FIGHT FOR REFUND BEWARE!!"
- e. "Had to be escalated to en eBay case,,, which I won EASILY!"
- f. "Never shipped 2 items, no communications and won Paypal refund..Unfortunate."
- g. "sells new item, but look like they should be used items in a mark down bin junk"
- h. "**PAUL IS A CROOK AND SCAM ARTIST! GOOGLE HIS COMPANY
 NAME U WILL SEE!**"
- i. "Poor! Business Practices! Disputing Never recd all pieces & not new RUDE"
- j. "buyer BBBBB ware"
- k. "Poor communication, had to get ebay involved, ebay refunded my money. Don't buy."
- 1. "Doesn't look anything like the pictures and took 4 days to get when tod 2!!! :("
- m. "took over two weeks to ship"
- n. "Jerk never shipped item or responded to any e-mails. Totally worthless scammer."
- o. "Scam artist, Fraud. Pictures aren't the product, don't have products listed"
- p. "Very low quality when being installed by shop the stitching came apart"
- q. "Description accurate. Delivery took over a month!!!!"
- r. "Wasn't satisfied with communication with seller."
- s. "Had to file claim for response from seller. Took three weeks to receive item!"
- t. "Never got item, not responding to messages"

- 22. As a direct consequence of Highway Stars and Boiko's past dealings with Castle, Castle's reputation in the Buick Community and the terms and conditions contained in the General Motors License Agreement, Highway Stars and Boiko took affirmative steps to prevent Castle from purchasing its products by placing Castle's "carguyjr" on its blocked bidder list. See Exhibit $B \ 26$.
- 23. On July 7, 2011, Highway Stars included eBay Item Nos. 13542428000, 140573300749 and 430542012142, a GNX OE AC Compressor Label, Visor Oil Recommendations Sticker and GNX Vehicle Emission Label respectively, on its eBay auction listing. See Exhibit G. These items are authentic General Motors restoration products, which are labeled with authentic General Motors restoration parts labels to substantiate the item's authenticity.
- 24. Prior to 10:24 p.m. on July 7, 2011, Castle attempted to purchase these items from Highway Stars through the eBay system under username "carguyjr".
- 25. At 10:24 p.m. on July 7, 2011, Castle sent an email to Boiko at Highway Stars inquiring into why he was prohibited from completing the transaction due to his being placed on the blocked bidder list. See Email from <u>castelguy129@yahoo.com</u> Attached as Exhibit H.
- 26. At approximately 10:52 p.m. on July 7, 2011, Castle employed username "pauljr129" to circumvent the block bidder list and eBay's policies and purchase the items from Highway Stars.
- 27. On July 8, 2011, Highway Stars contacted an eBay Trust and Safety Department representative to advise of Castle's direct violation of eBay policies and procedures. Thereafter, eBay generated Case No. 1-1195375070 to record its investigation of the matter and eBay

advised Highway Stars to refund the purchase and not complete the transaction by not shipping the products. See Exhibit J.

- 28. At 1:14 p.m. on July 8, 2011, Highway Stars processed a complete refund to Castle's "pauljr129". See Exhibit K.
- 29. In retaliation for being prohibited from bidding on Highway Stars' eBay auction site, on July 15, 2011, Castle published false, malicious, negative and unprovoked feedback on Highway Stars' eBay profile. *See Exhibit L.* Castle published the following statements on eBay:
 - a. "sells fuel senders claims are ac delco and ar not copys ac delco label spectra";
 - b. "be real careful this guy makes false statements make claims on parts!!"; and
 - c. "This guy be careful all his claims are not true never buy hi fuel sendor!!".
- 30. Castle had no factual basis for publishing any feedback let alone false and malicious feedback regarding a fuel sender he never purchased.
- 31. Castle's intent in publishing the false and malicious feedback was to harm Highway Stars and Boiko's professional and personal reputation and to endanger Highway Stars' licensing agreement with General Motors.
- 32. As a result of eBay's investigation into the matter, eBay removed Castle's negative feedback, the only negative feedback ever left for Highway Stars, from Highway Stars' eBay profile.
- 33. Prior to July 2011, Boiko, on behalf of Highway Stars, investigated Castle's and World of Motorworks' reputation within the Buick Community. See Exhibit B ¶ 30.
- 34. Prior to July 2011, Boiko uncovered several instances of disgruntled customers of Castle and World of Motorworks, including those that received products that were not as

advertised or defective, those who received products weeks or months after the alleged shipment date and those who never received their products, despite having paid in full. See Exhibit $B \parallel 31$.

- 35. One such representative sample of Castle's business practices discovered by Boiko was Brian Petruska. On July 12, 2010, Mr. Petruska bought and paid for a Buick Grand National rear end from Castle for his 1987 Monte Carlo SS. See Affidavit of Brian Petruska Attached as Exhibit M.
- 36. Over the course of several months, Mr. Petruska contacted Castle and was misled about the status of his purchase. Despite paying Castle \$1,449.00 for the part, he never received the part nor did he ever receive a refund. See Affidavit of Brian Petruska Attached as Exhibit M.
- 37. In an effort to either obtain the automotive part or receive a refund, Mr. Petruska sent letters to the Illinois Attorney General. The Illinois Attorney General responded that it was unable to locate Mr. Castle and was unable to assist in the resolution of the matter. See Affidavit of Brian Petruska Attached as Exhibit M.
- 38. In addition to Mr. Petruska, another representative sample of Castle's business practices is Arthur Swenson of Odenville, Alabama who filed a complaint with the Illinois Better Business Bureau ("BBB") under BBB Case No. 94362150. *A Copy of Swenson's BBB Complaint Record is Attached as Exhibit N.*
- 39. Mr. Swenson paid Castle \$470.00 for an automotive header panel, which was received by Mr. Swenson broken into three parts and completely unusable. Castle responded to Mr. Swenson with vulgarities and refused to accept any responsibility. *See Exhibit N*.
- 40. The BBB was unable to resolve the matter and Mr. Swenson was never credited or reimbursed for his purchase. *See Exhibit N.*

- 41. In May 2010, Robert Stefani filed a BBB action as a result of Castle's failure to reimburse Mr. Stefani for a t-top moulding cover that Mr. Stefani returned to Castle. Castle agreed to refund Mr. Stefani, but failed to do so. A Copy of Stefani's BBB Complaint Record is Attached as Exhibit O.
- 42. In July 2010, Mike Vando filed a BBB action as a result of Castle's failure to ship the automotive part Mr. Vando bought and paid for via World of Motorworks' eBay listing. A Copy of Vando's BBB Complaint Record is Attached as Exhibit P.
- 43. Mr. Vando left Castle and World of Motorworks negative feedback on the eBay page, to which Castle responded by telling Mr. Vando that he "is a real jagoff and to stick the part in [his] ass." The second email referred to Mr. Vando as a "dick head and said they figure that [he] owns a Ford". See Exhibit P.
- 44. In addition to the above individuals, Boiko discovered several former Castle customers that showcased their displeasure with Mr. Castle online. Mr. Castle has a reputation for using extremely threatening and vulgar language including but not limited to words depicting sexual acts and racial slurs in his responses to customers that confront Castle about never receiving their product, receiving a product that does not resemble the description and/or being fraudulently overcharged for the product. Also, Castle has a reputation for purchasing items, claiming they were damaged in the transit, demanding a refund and returning a completely different item. See Exhibit B ¶¶ 32 and 33, Exhibit M, N, O, P and O.
- 45. On information and belief, on more than one occasion, Castle threatened to travel to customer's residences and physically attack them. See Exhibit B \P 34 and Exhibit Q.

- 46. On information and belief, on July 14, 15, 19, 20 and 21 and August 6 of 2011, Castle called Highway Stars to harass and threaten Boiko, his company and his family. See Exhibit $B \parallel 29$.
- 47. It is clear that Castle has a reputation for dishonesty, engaging in deceptive practices and scamming customers out of their money. Further he is well-known for his reputation of making brash, foolish and reckless comments to those who question his business techniques and transactions. See Exhibit B \P 32 and 36.
- 48. On at least one occasion, Castle received a cease and desist letter from General Motors relating to his marketing of unlicensed General Motors products as licensed General Motors products. See Exhibit $B \, \P \, 23$.
- 49. Castle advised Boiko of this letter and told Boiko that if Castle received another cease and desist letter from General Motors then he would "wipe his ass with it". See Exhibit B \P 23.
- 50. EBay has identified Castle with shill bidding his own products to increase the auction price and purchasing his own products and leaving positive feedback so that he could inflate reputation on eBay. See Exhibit R where "carguyjr" leaves positive feedback for "turbochick129".
- 51. Since the commencement of this lawsuit and in an effort to improve his tarnished image, Castle has contacted several former customers and requested that they remove negative online postings. See Exhibit $B \, \P \, 37$.

COUNT I – DEFAMATION PER SE

52. Highway Stars realleges and incorporates Paragraphs 1 through 51 above into this Paragraph 52.

- 53. Castle posted false and malicious statements in the feedback section of Highway Stars eBay profile, which were available for all eBay users to review.
 - 54. As detailed in Paragraph 29, the false and malicious statements were as follows:
 - a. "sells fuel senders claims are ac delco and ar not copys ac delco label spectra";
 - b. "be real careful this guy makes false statements make claims on parts!!"; and
 - c. "This guy be careful all his claims are not true never buy hi fuel sendor!!".
- 55. Castle's false and misleading statements were posted on eBay, public internet forum, and therefore, published for the public at large to review.
- 56. Highway Stars notified an eBay Trust and Safety Department representative who investigated the matter, determined the statements to be malicious and false and, finally, removed the statements from Highway Stars' profile and the eBay profile.
- 57. Such false statements identified in Paragraph 54 prejudice Highway Stars and Boiko and impute lack of ability in their trade, profession and business because the statements allege that Highway Stars and Boiko falsely misrepresent their GM licensed products to their customer base, which severely endangers Highway Stars' licensing agreement with General Motors, the substantial source of Highway Stars' revenue.
- 58. As a proximate result of Castle's malicious and false statements, Highway Stars and Boiko suffered damages to their business reputation and personal reputation, respectively, because the statements endangered Highway Star's licensing agreement with General Motors and disparaged Highway Stars' products before its customer base.
- 59. WHEREFORE, Defendants/Counter-Plaintiffs, Glen Neal Boiko and Highway Stars, Ltd., prays for judgment in its favor and against Plaintiff/Counter-Defendant, Paul Castelbuono, a/k/a "Paul Castle" and d/b/a "World of Motorworks" for defamation per se for

damages in excess of the jurisdictional amount to be proved at trial, plus attorney's fees, costs and for additional relief as this Court deems reasonable and just.

COUNT II - FALSE LIGHT INVASION OF PRIVACY

- 60. Highway Stars realleges and incorporates Paragraphs 1 through 59 above into this Paragraph 60.
 - 61. Castle's statements published on eBay were false, misleading and malicious.
 - 62. As detailed in Paragraph 29, the false and malicious statements were as follows:
 - a. "sells fuel senders claims are ac delco and ar not copys ac delco label spectra";
 - b. "be real careful this guy makes false statements make claims on parts!!"; and
 - c. "This guy be careful all his claims are not true never buy hi fuel sendor!!".
- 63. Based on Highway Stars' reputation for accurate advertising, fair pricing and impeccable customer service, Castle's claim that Highway Stars copies labels and misrepresents parts and makes false statements regarding its products is untruthful and malicious.
- 64. Castle's untruthful statements placed Highway Stars and Boiko in a false light before all eBay users, the Buick Community, former and prospective Highway Stars customers and the general public.
- 65. Castle's statements maliciously attacked Highway Stars and Boiko's integrity, professionalism and the products they sell to Buick Grand National, GNX and Turbo Buick enthusiasts.
- 66. Highway Stars and Boiko have worked since 2006 to establish a reputation for providing high quality products, knowledgeable service and trusted business dealings.

- 67. Castle's publication of false and malicious statements claims that Highway Stars misrepresents the products that it sells was an attack on Highway Stars and Boiko's professionalism and reputation and was highly offensive because such statements were untrue.
- 68. The publication of false and malicious statements regarding the integrity and professionalism of a retail business would be highly offensive to the reasonable person.
- 69. Highway Stars has never misrepresented any of its products or made false claims regarding its products.
- 70. Castle has never purchased any product from Highway Stars that was inaccurately labeled nor has Castle identified any other individual or business that purchased any product from Highway Stars that was inaccurately labeled.
- 71. On information and belief, Castle is aware of Highway Stars' positive reputation in the Buick Community and, therefore, published the malicious statements knowing them to be false.
- 72. Castle published the statements on eBay with reckless disregard for whether the statements were true or false because he did not undertake any factual investigation into the truth of the statements prior to publication nor did he provide any factual support for such statements.
- 73. WHEREFORE, Defendants/Counter-Plaintiffs, Glen Neal Boiko and Highway Stars, Ltd., prays for judgment in its favor and against Plaintiff/Counter-Defendant, Paul Castelbuono, a/k/a "Paul Castle" and d/b/a "World of Motorworks" for false light invasion of privacy for damages in excess of the jurisdictional amount to be proved at trial, plus attorney's fees, costs and for additional relief as this Court deems reasonable and just.

COUNT III - COMMERCIAL DISPARAGEMENT

- 74. Highway Stars realleges and incorporates Paragraphs 1 through 73 above into this Paragraph 74.
- 75. As identified in Paragraph 29, Castle published false and demeaning statements on Highway Stars' eBay profile regarding the integrity of Highway Stars and the quality of its products and services.
- 76. The publication of such false and demeaning statements directly targeted Highway Stars and the quality of its products and services because the statements were published on Highway Stars' eBay profile and specifically identified Highway Stars' products.
- 77. WHEREFORE, Defendants/Counter-Plaintiffs, Glen Neal Boiko and Highway Stars, Ltd., prays for judgment in its favor and against Plaintiff/Counter-Defendant, Paul Castelbuono, a/k/a "Paul Castle" and d/b/a "World of Motorworks" for commercial disparagement for damages in excess of the jurisdictional amount to be proved at trial, plus attorney's fees, costs and for additional relief as this Court deems reasonable and just.

COUNT IV – VIOLATION OF THE UNIFORM DECEPTIVE TRADE PRACTICES ACT

- 78. Highway Stars realleges and incorporates Paragraphs 1 through 77 above into this Paragraph 78.
- 79. As stated in Paragraph 29, Castle published false and demeaning statements on eBay regarding the integrity of Highway Stars and the quality of its products and services.
- 80. As stated above, Castle published statements, which specifically identified Highway Stars' products, disparaged the goods, services and business of Highway Stars by publishing false and misleading representations of fact.
- 81. Castle published such comments in the course of his business, vocation and occupation as an officer, director and/or owner of World of Motorworks.

- 82. The publication of such false and malicious statements is a direct violation of the Uniform Deceptive Trade Practices Act because the publication directly attacks Highway Stars' products and threatens its compliance with its licensing agreement with General Motors.
- 83. Highway Stars is entitled to costs and attorneys' fees under Section 3 of the Uniform Deceptive Trade Practices Act.
- 84. WHEREFORE, Defendants/Counter-Plaintiffs, Glen Neal Boiko and Highway Stars, Ltd., prays for judgment in its favor and against Plaintiff/Counter-Defendant, Paul Castelbuono, a/k/a "Paul Castle" and d/b/a "World of Motorworks" for violation of the Uniform Deceptive Trade Practices Act for damages in excess of the jurisdictional amount to be proved at trial, plus attorney's fees, costs and for additional relief as this Court deems reasonable and just.

COUNT V – TORTIOUS INTERFERENCE WITH BUSINESS RELATIONSHIPS

- 85. Highway Stars realleges and incorporates Paragraphs 1 through 84 above into this Paragraph 85.
- 86. Castle's published false and malicious statements on eBay that he knew or should have known were false. The statements attacked the integrity and professionalism of Highway Stars and claimed that Highway Stars falsely identifies its products to eBay users, the Buick Community, former and prospective Highway Stars customers and the general public.
- 87. In addition, current customers of Highway Stars, those who frequent Highway Stars website and eBay retail store, viewed the false and malicious statements made by Castle.
- 88. Castle's false and malicious statements regarding Highway Stars' professionalism truthfulness and integrity as well as Castle's demeaning statements regarding Highway Stars' products tortiously interfered with Highway Stars' business relationships with its customers and

General Motors because it stated that Highway Stars falsely labeled licensed products, which, if true, would be a violation of its licensing agreement with General Motors.

- 89. The termination of the licensing agreement with General Motors would result in a severe decrease in sales for Highway Stars and a loss of customers.
- 90. Castle's false and malicious statements were made to entice Highway Stars' current customers and vendors to cease doing business with Highway Stars and, instead, do business with World of Motorworks.
- 91. Castle's disparaging comments about Highway Stars tortuously interfered with Highway Stars' current business relationships and prospective business relationships with its customers and vendors because it claimed that Highway Stars made false claims regarding the products it sells, which could result in a loss of consumer confidence and the termination of the licensing agreement with General Motors.
- 92. Castle, knowing that Highway Stars is licensed to sell GM products, knew or should have known that his actions would interfere with Highway Stars' established business relationships with its customers and vendors.
- 93. WHEREFORE, Defendants/Counter-Plaintiffs, Glen Neal Boiko and Highway Stars, Ltd., prays for judgment in its favor and against Plaintiff/Counter-Defendant, Paul Castelbuono, a/k/a "Paul Castle" and d/b/a "World of Motorworks" for tortious interference with business relationships for damages in excess of the jurisdictional amount to be proved at trial, plus attorney's fees, costs and for additional relief as this Court deems reasonable and just.

COUNT VI – TORTIOUS INTERFERENCE WITH A PROSPECTIVE ECONOMIC ADVANTAGE

94. Highway Stars realleges and incorporates Paragraphs 1 through 93 above into this Paragraph 94.

- 95. Highway Stars generates revenue from its transactions on eBay and continues to build its reputations as a five star internet retailer.
- 96. Highway Stars forms valid business relationships with eBay buyers and reasonably expects to continue entering into valid business relationships with eBay buyers.
- 97. Castle has knowledge of Highway Stars eBay presence because he has attempted to purchase products from Highway Stars' eBay retail store. In addition, Castle knows that Highway Stars conducts business on eBay on a continuous basis with an expectation of continuing to conduct business on eBay.
- 98. Castle's false and malicious statements were made to intentionally interfere with Highway Stars expectation that it would continue to enter into valid business relationships with the Buick Community and the general public through its eBay listing page and redirect that business to Castle.
- 99. Castle's false and malicious statements were made to intentionally interfere with Highway Stars' licensing agreement with General Motors, the source of the new original licensed products it supplies to the Buick Community.
- 100. Castle's false and malicious statements prevented Highways Stars from entering into valid business relationships with the Buick Community, Buick Grand National, GNX and Turbo Buick enthusiasts and the general public through its eBay listing page and the Highway Stars website.
- 101. As a result of its false and malicious statements, Highway Stars suffered damages in the form of lost sales, loss of business reputation and loss of goodwill.
- 102. WHEREFORE, Defendants/Counter-Plaintiffs, Glen Neal Boiko and Highway Stars, Ltd., prays for judgment in its favor and against Plaintiff/Counter-Defendant, Paul

Castelbuono, a/k/a "Paul Castle" and d/b/a "World of Motorworks" for tortious interference with a prospective economic advantage for damages in excess of the jurisdictional amount to be proved at trial, plus attorney's fees, costs and for additional relief as this Court deems reasonable and just.

AFFIDAVIT OF GLEN N. BOIKO

- I, Glen N. Boiko, being duly sworn on oath, depose and state as follows:
- 1. I am over the age of 18, I have personal knowledge of the foregoing and I am competent to testify to the foregoing should I be called to do so.
- 2. I am the President and owner of Highway Stars, Ltd. ("Highway Stars").
- 3. I currently reside in Northbrook, Illinois.
- 4. Highway Stars is an Illinois corporation in Good Standing with the Illinois Secretary of State.



- 5. Highway Stars' principal place of business is located at 1556 St. Paul Avenue, Gurnee, Illinois.
- 6. Highway Stars has been in business since 2006.
- 7. Highway Stars is an authorized supplier of specialized, new original and genuine General Motors automotive parts and original equipment manufacturer ("OEM") parts for the Buick Grand National, Turbo Regal and GNX automobiles.
- 8. Highways Stars is an authorized stocking jobber of AC Delco parts and an authorized stocking distributor of Delphi parts.
- 9. Highway Stars is an official Authorized GM Restoration Parts licensee.
- 10. Highway Stars is an official General Motors Service Parts Operations Program licensee.
- 11. Highway Stars distributes all of its licensed products pursuant to the General Motors License Agreement.
- 12. Any violation of the General Motors License Agreement would terminate Highway Stars' contractual right to distribute specialized, new and genuine General Motors automotive parts and original equipment manufacturer ("OEM") parts for the Buick Grand National, Turbo Regal and GNX automobiles.
- 13. The General Motors License Agreement provides, in relevant part, "Licensee agrees that it shall not conduct any activity or produce goods which it knows or should know will in any way question Licensee's ethics or lawful practices, nor shall Licensee . . . do anything which it knows or should know will damage or reflect adversely upon Licensor (including its image, reputation, and products), the Licensed Products, and/or the Licensed Trademarks (and other GM Trademarks)."

- 14. The termination of the General Motors License Agreement would severely disrupt Highway Stars' business including but not limited to the loss of significant revenue and the loss of customers that count on the distribution of licensed and new original General Motors products for the Buick Grand National, Turbo Regal and GNX automobiles.
- 15. Highway Stars' sales and revenue are primarily derived from its website, www.nos4gn.com, which displays images of its inventory and information pertaining to the history, use and installation of the products.
- 16. Highway Stars also derives a significant amount of sales and revenue from its eBay retail store, where it operates under the name "nos4gn_highwaystars".
- 17. Highway Stars currently possesses a perfect positive feedback record from customers that purchased items from the Highway Stars' eBay retail listing.
- 18. Highway Stars has a five star (highest) customer satisfaction rating and is regarded as an eBay Top Rated Seller.
- 19. Among Buick Grand National, Turbo Regal and GNX enthusiasts and collectors ("Buick Community"), Highway Stars is a very highly respected and trusted supplier of new, genuine, original and official General Motors, AC Delco and Delphi automotive parts.
- 20. World of Motorworks, owned by Paul Castelbuono a/k/a Paul Castle ("Castle"), is not an authorized stocking jobber of AC Delco parts, is not an authorized stocking distributor of Delphi parts and is not licensed to sell/produce new original and official General Motors restoration parts.
- 21. Castle has a reputation within the Buick Community for purchasing new, genuine, original and official General Motors, AC Delco and Delphi automotive parts from Highway Stars and

- other retailers and creating counterfeit replicas that he then markets as "authentic", "original" and/or "rare" at market price, without disclosing that the products are counterfeit.
- 22. Castle informed me that he previously received a cease and desist letter from General Motors related to Castle's unlawful marketing of unlicensed General Motors products as licensed General Motors products.
- 23. Specifically, Castle advised me that if he received another cease and desist letter, he would "wipe his ass with it."
- 24. In light of Castle's reputation for improper reproductions, deceptive marketing and unethical business dealings, Highway Stars, in compliance with the General Motors License Agreement, ceased all contact, including business transactions, with Castle and World of Motorworks.
- 25. Castle and World of Motorworks engage in buying and selling transactions on eBay under usernames "carguyjr", "pauljr129" and "turbochick129".
- 26. Due to Castle's reputation in the Buick Community and in accordance with eBay policies, Highway Stars blocked Castle from purchasing items from Highway Stars' eBay retail listing.
- 27. On July 15, in response to Castle being blocked from buying Highway Stars' products on eBay, Castle, under username "pauljr129", published false and malicious feedback on Highway Stars' eBay profile.
- 28. Castle has a reputation for threatening those that question and/or criticize his deceptive business practices.
- 29. On information and belief, on July 14, 15, 19, 20, 21 and August 6, 2011, Castle called Highway Stars' office and harassed and threatened me, my company and my family.

- 30. Prior to July 2011, I further investigated Castle and his business dealing in the Buick Community.
- 31. Prior to July 2011, my investigation revealed several instances where customers of World of Motorworks never received the items they purchased, received defective and/or broken items when the items were, in fact, advertised as new and original, were double billed for their purchase or received their items weeks or months after the date of purchase.
- 32. In addition, I discovered instances where Castle contacted World of Motorworks customers that complained that they never received their purchased items or a return of their money and referred to them with extreme vulgarities including racial slurs. There were also instances where Castle identified sexual acts he would perform on either the customer or his or her family.
- 33. Castle also has a reputation for purchasing automotive products and then returning a similar but different item in its place complaining that it was defective.
- 34. On information and belief, on more than one occasion, Castle threatened to travel to a customer's residence to physically attack that customer.
- 35. Further, I corresponded with former World of Motorworks customers that notified the Illinois Attorney General and the Illinois Better Business Bureau in an effort to be made whole and make a public record of World of Motorworks deceptive business dealings.
- 36. It is well-documented in the Buick Community that Castle has a reputation for dishonesty.
- 37. On information and belief, since the commencement of this lawsuit and in an effort to improve his tarnished image, Castle has contacted several former customers and requested that they remove negative online postings.

He knew he was blocked and since he was not able to contact us through ebay, he sent us an emai to our address: ebay@nos4gn.com on July 7th late at night 10:24pm, asking us why he was blocked. We have attached a copy of his email.(see attachment) It is signed by Paul Castle, and comes from the email address: castelguy129@yahoo.com I will be glad to fax you the email, if you can not open this attachment.

On July 8th, after talking with Jillene in ebay (case # 1-1195375070) , to report this member, she did direct us to refund the money. He did not receive any product, and the money was immediately refunded on July 8th at 11: 14 PDT after our conversation with Ebay. We refunded his entire purchase on July 8th through paypal. (see second attachment) We did tell Jillene (ebay- case # 1-1195375070 that we wanted to have ebay cancel the transaction, because even after refunding the money, we were concerned he would leave us a neg feedback. Jillene said not to worry about that, since ebay would take care of this. He is angry that we have blocked him and has been calling us to harrass us on the phone. We have phone records too. Now, recently he contacted you giving you some sob story which is a lie.





Well, it was destined to happen. Sooner or later, when you deal with enough vendors online, you run into the inevitable clip artist. This page is dedicated to telling the whole world just what a dastardly villain I have had the great misfortune to become entangled with. Criminal of the day... Paul Castlebuono and World of Motorworks. I tweaked his webpage logo (below), to better reflect his business practices.

probably thinking (more power to you if you are) that this is just a guy who's disappointed with an online purchase. Au contraire mon frere... presented lierein are all the facts from the very beginning. Digest the information and stay far, far away from World of Motorworks my friends.

On Monday July 12th I received the invoice for the item I had purchased from World of Motorworks. The total was 1,200,00 dollars plus 249.00 shipping for a total of 1,449.00 dollars. On Tuesday, July 13th, I received email confirmation that my payment had been received. On Friday July 23rd, I emailed the vendor inquiring about delivery notification. He replied the same day that he had broken his foot and he would call me with the freight information on July 27th.

Thus began the odyssey of my stupidity (in trusting an eBay vendor) in using eBay as one would a trusted merchant. And if you think you're protected by using PayPai, think again pai. They'll only protect you if you file a "INR" (Item not received) claim within 30 days. *However* PayPai stacks the deck in their favor (like any other bank) by urging you to resolve any issues you have with a seller between the two of you. This is what I did... and now it is one COLOSSAL MESSI.

Timeline of events:

Monday, July 12th 2010: I received the invoice for the Buick Grand National rear end I had purchased from World of Motorworks, via an eBay "buy it now" auction. The total was 1,200.00 dollars plus 249.00 shipping for a total of 1,449,00 dollars.

Tuesday, July 13th 2010: I received email confirmation that my payment had been received. On Friday July 23rd, I emailed the vendor inquiring about delivery notification. He replied the same day that he had broken his foot and he would call me with the freight information on Tuesday July 27th.

Saturday, July 31st 2010: I received an email telling me Paul Castelbuono (the vendor) had some health issues and wouldn't be in the office until Tuesday August 3rd, and I was provided with his cell phone number. After a week, I gave him a call.

Tuesday, August 10th 2010: I called Paul's cell phone at 2:56 p.m. and was informed that his voicemail was full. Then I called the World of Motorworks business phone at 4:46 p.m. and left a message to call me back.

Tuesday. August 10th 2010: Paul called me at 8:01 p.m. and explained he was having some serious health issues (in the hospital due to complications with his type one diabetes and almost lost the sight in his one remaining eye) and agreed to ship the Buick rear endias soon as possible:

<u>Tuesday. September 14th 2010</u>: I again placed a phone call to Paul's cell phone at 4:29 p.m. and once again, I was rewarded with the voicemail is full message.

Tuesday. September 14th 2010: 4:47pm 630-264-8070 Logan asked how he could help. I asked for an update. He promised to call back with information, but naturally, he did not.

Tuesday. September 14th 2010: Having had enough, I emailed Paul requesting a refund. He replied at 11:32pm that he was sorry and he'd call me the next day, the 15th. He did not call me back.

Thursday. September 16th 2010: I again placed a phone call to Paul's cell phone at 2:40 p.m. and once again, I was rewarded with the volcemall is full message. I tried once again at 6:53 p.m. and got the same automated message.

Friday, September 17th 2010: With no other recourse, I called PayPal customer service at 6:00 p.m. and was quickly connected with a dispute specialist named Patrick. Naturally, the first words out of his mouth were that a dispute could not be filed because it was past their 30 day window of opportunity to file a dispute. He

dld say however, that since it was a significant amount of money he would start an investigation and email me the results.

Saturday, September 18th 2010: Received email confirmation at 6:05pm from PayPai regarding my INR (Item Not Received) dispute concerning this transaction. Other than this acknowledgement I never heard from them again.

Monday, September 20th 2010: I once again called the World of Motorworks main number at 12:00 p.m. Logan answered and (for the umpteenth time) asked him to check on my shipment, gave him description and eBay auction number. Said he would check and call me back.

<u>Tuesday. September 21st 2010</u>: Logan called me around 1:30 p.m. to explain that the rear end was in rural PA and they could not get any freight company to pick up the unit. He said he and the owner were going themselves on October 7th to pick up the rear end and that it would be shipped on October 27th.

Okay... let's pause a minute here to reflect on the paragraph above. These guys were selling something that they expected to be getting in. THIS WAS NOT AN ITEM THEY HAD AT THEIR SHOP! Yet through all the phone calls and emails, these guys continued to advertise auctions for the same damned thing that they still have not (to this day) ever sent to me! He has my money and the part which was promised.

Friday, October 29th 2010: I once again called the World of Motorworks main number and asked for another update. I mentioned when the rear end had been scheduled to be picked up and when it was supposed to have been shipped. He asked if I spoke with Logan and I said that I had. He said Logan was out of the shop but should be back in 45 minutes or so and field have Logan call me back.

Tuesday, November 2nd 2010: I was stunned to receive a phone call around 3:23 p.m. from Paul, explaining how (you've got to love their flair for the dramatic) Logan was out sick with tonsillits and that the rear end that went out this morning was the one headed for me. Paul said he would text Logan to get the specifics and that he would (drum roll please) call me back. Clearly these guys missed their calling, they should be out in Hollywood writing television scripts.

<u>Thursday</u>, <u>November 4th 2010</u>: I again called the World of Motorworks main number at 5:15 p.m. and asked for another update. Paul said he was waiting for confirmation from shipping company whether pickup would be today or tomorrow. He said as soon as he had confirmation he would contact me with a tracking number and shipping information.
